

#### **Recommendations & Decisions**

prefer receiving health education through periodic video clips that present healthcare topics in a simple and clear manner. Meanwhile, 24% of participants preferred receiving education during their presence in the hospital while waiting for their appointment. Additionally, 17% of participants selected the option of periodic live sessions with a specialized consultant, whereas only 14% considered the periodic newsletter to be the most appropriate method.



The production and publication of periodic short video content for health education will be adopted as the primary awareness channel, as it represents the most preferred method among participants. The focus will be on simplifying the content and presenting it in a clear and engaging manner to ensure easier understanding.




